



## REGULATION

### ART.1 ORGANIZATION

THE COMPANY PCS SANMICHELESE SSD ARL ANNOUNCES AND ORGANIZES AN INTERNATIONAL TOURNAMENT CALLED XIII MEMORIAL NARDINO PREVIDI IN COLLABORATION WITH THE MUNICIPALITIES OF SASSUOLO, FIORANO AND CASTELLARANO WHICH WILL BE HELD ON 28/29/30/31 AUGUST AND 01 SEPTEMBER 2024

### ART:2 PARTICIPATION CATEGORY AND AGE LIMITS

THE TOURNAMENT IS RESERVED FOR FOOTBALLERS BELONGING TO THE UNDER 17 CATEGORY REGISTERED WITH THEIR OWN COMPANY AND FEDERATION FOR THE CURRENT SEASON.

UNDER 17 BORN BETWEEN 01/01/2008 AND THEIR AGE IS 14.

PROFESSIONAL CLUBS WILL PLAY WITH THE UNDER 16 CATEGORY.

### ART.3 LOANS

LOANS ARE ALLOWED, A MAXIMUM OF 3 (THREE) PER TEAM, NON-INTERCHANGEABLE AND VALID FOR THE ENTIRE DURATION OF THE TOURNAMENT, UPON PRESENTATION OF A REGULAR CLEARANCE ISSUED BY THE CLUB TO WHICH THEY BELONG, WHICH CANNOT BE AMONG THE PARTICIPANTS IN THE TOURNAMENT.

### ART.4 PLAYER LISTS

THE PARTICIPATING CLUBS MUST SUBMIT TO THE TOURNAMENT ORGANIZATION, BEFORE THE START, THE LIST OF PLAYERS THEY INTEND TO USE, UP TO A MAXIMUM OF 22 AFTER THEIR DELIVERY. IT IS PROHIBITED TO MAKE CHANGES TO THESE LISTS. THE LIST TO BE SUBMITTED TO THE REFEREE BEFORE THE MATCH WILL INDICATE UP TO A MAXIMUM OF 20 PLAYERS.

### ART.5 SUBSTITUTIONS

7 SUBSTITUTIONS ARE ALLOWED, REGARDLESS OF THE ROLE, AT ANY THREE MOMENTS OF THE MATCH, IN ADDITION TO THE INTERVAL BETWEEN THE FIRST AND SECOND HALF

### ART.6 PARTICIPATING CLUBS

#### **ART.7 TOURNAMENT FORMULA**

THE TOURNAMENT WILL BE HELD WITH THE FOLLOWING FORMULA AND QUALIFICATION METHOD: QUALIFICATION PHASE WITH THREE GROUPS OF 4 TEAMS, EACH TEAM WILL PLAY THREE ONE-WAY MATCHES, WITH A FINAL RANKING BY ROPE-RODUCING POINTS. THE FIRST IN EACH GROUP AND THE BEST SECOND IN THE THREE GROUPS WILL QUALIFY FOR THE SEMI-FINAL MATCHES. THE TEAMS QUALIFIED FOR THE SEMI-FINAL MATCHES WILL BE PAIRED BY DRAWING WITH DIRECT ELIMINATION MATCHES. IN THE EVENT OF A DRAW AT THE END OF REGULAR TIME, PENALTY KICKS WILL BE DIRECTLY TAKEN WITH THE METHODS SET OUT IN ART. 10. THE TWO TEAMS LOSING THE SEMI-FINALS WILL BOTH BE CLASSIFIED IN 3RD PLACE. THE TWO TEAMS WINNING THE SEMI-FINALS WILL PLAY THE FINAL FOR 1ST AND 2ND PLACE. IN THE EVENT OF A DRAW AT THE END OF REGULAR TIME, PENALTY KICKS WILL BE TAKEN DIRECTLY IN ACCORDANCE WITH THE TERMS SET OUT IN ART. 10.

#### **ART.8 RANKINGS**

THE RANKINGS WILL BE DRAWN UP ON THE BASIS OF THE FOLLOWING CRITERIA:

3 POINTS FOR A VICTORY - 1 POINT FOR A DRAW - 0 POINTS FOR A DEFEAT IN THE EVENT OF A TIED SCORE, THE CRITERIA LISTED IN ORDER APPLY:

RESULT OF HEAD-TO-HEAD MATCHES  
GOAL DIFFERENCE IN HEAD-TO-HEAD MATCHES BETWEEN TEAMS WITH THE SAME POINTS  
GOAL DIFFERENCE ON THE TOTAL MATCHES PLAYED IN THE GROUP  
GREATER NUMBER OF GOALS SCORED ON THE TOTAL MATCHES PLAYED IN THE GROUP  
RANKING DISCIPLINE DRAW.

#### EVALUATION OF THE BEST SECOND PLACE TEAM

THE TEAMS PLACED IN SECOND PLACE IN EACH OF THE 3 GROUPS WILL BE EVALUATED ACCORDING TO THE FOLLOWING CRITERIA: BEST SCORE ACHIEVED AT THE END OF THE MATCHES IN THE QUALIFICATION PHASE IN THE EVENT OF A DRAW  
BEST GOAL DIFFERENCE IN THE MATCHES IN THE QUALIFICATION PHASE IN THE EVENT OF A FURTHER DRAW  
HIGHEST NUMBER OF GOALS SCORED OUT OF THE TOTAL MATCHES PLAYED IN THE QUALIFICATION PHASE  
DRAW

#### **ART.9 HALF OF THE MATCH**

THE MATCHES WILL BE PLAYED IN 2 (TWO) HALFS EACH LONGING 35'





**ART.10 PENALTY SHOTS (PLEASED FOR THE FINALS, SEMIFINALS)**

IN THE EVENT OF A DRAW AT THE END OF THE TWO REGULAR HALF-TIME, PENALTY THROWS WILL BE TAKEN IN ACCORDANCE WITH THE METHODS ESTABLISHED BY RULE 10 POINT 3 OF THE RULES OF THE GAME AND DECISIONS.

**ART. 12 REFEREES**

THE MATCHES WILL BE DIRECTED BY FIGC / AIA REFEREES

**ART. 13 TOURNAMENT COMMITTEE**

A TOURNAMENT COMMITTEE WILL BE ESTABLISHED WHICH WILL BE RESPONSIBLE FOR ANY DISPUTE, PROTEST, COMPLAINT OR UNFORESEEN CIRCUMSTANCES.

THE COMMITTEE WILL NOT ACCEPT PROTESTS OR COMPLAINTS ON DECISIONS TAKEN BY REFEREES.

THE COMMITTEE WILL REPORT TO ITS NATIONAL OR INTERNATIONAL FEDERATION RESPONSIBLE FOR TAKING THE MEASURES DEEMED APPROPRIATE EVERY PLAYER AND EVERY MEMBER OF THE PARTICIPATING DELEGATIONS FOUND TO BE GUILTY OF UNSPORTSMANSHIP CONDUCT DURING THE TOURNAMENT

**ART.14 TOURNAMENT DISCIPLINE**

THE DISCIPLINE OF THE TOURNAMENT IS ENTRUSTED TO THE SPORTS JUDGE OR ALTERNATE OF THE COMPETENT COMMITTEE

**ART.15 AUTOMATISM OF SANCTIONS**

THE AUTOMATISM OF SANCTIONS IS PROVIDED FOR WITH THE FOLLOWING METHODS: THE PLAYER EXPELLED DURING A

**ART.16 COMPLAINTS**

ANY COMPLAINTS MUST BE SUBMITTED WITHIN 30 MINUTES OF THE END OF THE MATCH ACCOMPANIED BY A FEE OF EURO 50.00 (FIFTY); A COPY OF THE COMPLAINT MUST BE DELIVERED TO





THE COUNTERPARTY ALWAYS WITHIN 30 MINUTES. THE COMPLAINT FEE MUST BE PAID TO THE COMPETENT COMMITTEE OR DELEGATION

**ART. 17 INSURANCE**

IT IS THE RESPONSIBILITY OF EACH PARTICIPATING CLUB TO ENSURE INSURANCE COVERAGE FOR ITS PLAYERS. THE TOURNAMENT ORGANIZATION IS RESPONSIBLE FOR THE REGULARITY OF THE INSURANCE COVERAGE

**ART.18 I.F.A.B.**

MATCHES ARE PLAYED IN ACCORDANCE WITH THE CURRENT EDITION OF THE INTERNATIONAL FOOTBALL ASSOCIATIONS BOARD (IFAB) RULES.

**ART.19 GENERAL RULES**

FOR ANYTHING NOT PROVIDED FOR IN THESE REGULATIONS, THE PROVISIONS OF THE FEDERAL REGULATIONS APPLY AS COMPATIBLE, AND THOSE REPORTED IN THE OFFICIAL NOTICE N°1 OF THE YOUTH AND SCHOOL SECTOR RELATING TO THE CURRENT SPORTS SEASON.
